RE: NOTICE OF DATA BREACH

Sunflower Medical Group, P.A. ("Sunflower") values and respects the privacy of your information, which is why we are writing to advise you of a recent incident that involved some of your personal information. We have no evidence to believe that your personal information has been misused for the purpose of committing fraud or identity theft. Nonetheless, we are writing to advise you about the incident and to provide you with guidance on what you can do to protect yourself, should you feel it is appropriate to do so.

What Happened? On January 7, 2025, Sunflower learned that an unauthorized third party had potentially accessed Sunflower's systems and acquired copies of certain files. Upon learning of the incident, Sunflower promptly took steps to further secure its systems and engaged a forensic security firm to assist with Sunflower's investigation of the incident. The investigation determined that an unknown third party accessed Sunflower's systems on or about December 15, 2024, and acquired copies of certain files from our systems as a part of the incident.

**What Information Was Involved?** We are notifying all individuals whose personal information may have been accessed and acquired during the incident. On February 24, 2025, we determined that the files contained some of your personal information, including your <<data elements>>.

What We Are Doing. In addition to the actions described above, we are taking steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. Although we are not aware of any instances of fraud or identity theft involving your information, we are also offering a complimentary one-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on prompt identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. What You Can Do. While we have no evidence that your personal information has been misused as a result of this incident, we encourage you to take advantage of the complimentary credit monitoring included in this letter. **Fraud Alerts:** By law, you have the right to place a fraud alert on your credit report if you believe you have been, or are about to become, a victim of fraud or related crime. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. <u>Credit and Security Freezes</u>: By law, you have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company. Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
